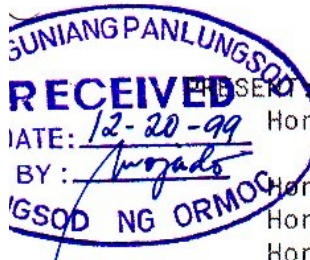

EUFROCINO M. CODILLA, SR., TO ENTER INTO AND SIGN FOR
AND IN BEHALF OF THE CITY GOVERNMENT OF ORMOC, A
MEMORANDUM OF AGREEMENT WITH THE NATIONAL HOUSING
AUTHORITY, FOR THE IMPLEMENTATION OF THE POVERTY
ALLEVIATION FUND-TWO (PAF-2) PROJECT.

hence, be accorded due course of action;


WHEREFORE, foregoing premises considered, on motion of City

IMPLEMENTATION OF THE POVERTY ALLEVIATION FUND-TWO (PAF-2) PROJECT;


