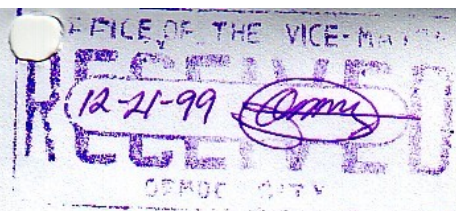
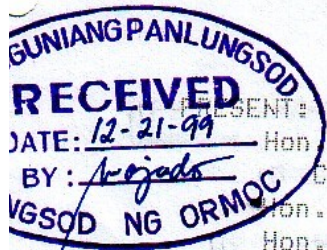

RESOLUTION NO. 99-222

A RESOLUTION APPROVING BARANGAY ORDINANCE NO. 02 SERIES
OF 1999 OF BARANGAY HIBUNAON, THIS CITY, ENTITLED: "AN
ORDINANCE PENALIZING PERSONS OR PERSONS MAKING
CONNECTIONS AND TAPPING OF WATER SUPPLY OF THE BARANGAY
WITHOUT PRIOR AUTHORITY OR CONSENT FROM THE SANGGUNIANG
PAMBARANGAY OF HIBUNAON, CITY OF ORMOC."

WHEREAS, this Sanggunian is in receipt of Barangay Ordinance No. 1,
series of 1999 of Barangay Hibunaon, this city, entitled, "AN ORDINANCE
PENALIZING PERSONS OR PERSONS MAKING CONNECTIONS AND TAPPING OF WATER
SUPPLY OF THE BARANGAY WITHOUT PRIOR AUTHORITY OR CONSENT FROM THE
SANGGUNIANG PAMBARANGAY OF HIBUNAON, CITY OF ORMOC";

WHEREAS, the Sangguniang Panlungsod ng Ormoc, in relation to the
aforecited ordinance at issue (and all other ordinances of the
Sangguniang Barangay in Ormoc City), is by law, granted the Power of
