

MHEREAS, this Sanggunian is in receipt of Resolution No. 03 s. 1999 the City Development Council, entitled: "A RESOLUTION APPROVING THE LOCAL DEVELOPMENT INVESTMENT PLAN OF THE CITY OF ORMOC FOR THE YEAR 2000-2004 AND REQUESTING THE HONORABLE SANGGUNIANG PANLUNGSOD FOR APPROVAL AND ENDORSEMENT OF THE SAME, TO THE REGIONAL DEVELOPMENT COUNCIL (RDC), NEDA, PALO, LEYTE";

WHEREAS, the Honorable City Mayor Eufrocino M. Codilla, Sr., through 1st Indorsement dated 7 December 1999, endorsed to the Secretary to the Sangguniang Panlungsod ng Ormoc CDC Resolution No. 03 s. 1999 for appropriate legislative action:

WHEREAS, said Resolution No. 3 s. 1999 has stated that the Local Government Code of 1991 asserts that "each local government unit shall have a comprehensive multi-sectoral investment plan" and that the same is, formulated by the City Planning and Development Office coordination with all barangay chairmen, local and line agencies;

WHEREAS, after thorough discussion, this august Body has found outthat said plan is within the development thrust of the city;
