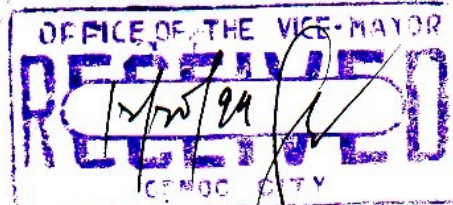

A RESOLUTION APPROVING THE CITY DEVELOPMENT COUNCIL'S
RESOLUTION NO. 03 SERIES OF 1999, ENTITLED: "A
RESOLUTION APPROVING THE LOCAL DEVELOPMENT INVESTMENT
PLAN OF THE CITY OF ORMOC FOR THE YEAR 2000-2004 AND
REQUESTING THE HONORABLE SANGGUNIANG PANLUNGSOD FOR
APPROVAL AND ENDORSEMENT OF THE SAME, TO THE REGIONAL
DEVELOPMENT COUNCIL (RDC), NEDA, PALO, LEYTE."

WHEREAS, this Sanggunian is in receipt of Resolution No. 03 s. 1999
from the City Development Council, entitled: "A RESOLUTION APPROVING
THE LOCAL DEVELOPMENT INVESTMENT PLAN OF THE CITY OF ORMOC FOR THE YEAR
2000-2004 AND REQUESTING THE HONORABLE SANGGUNIANG PANLUNGSOD FOR
APPROVAL AND ENDORSEMENT OF THE SAME, TO THE REGIONAL DEVELOPMENT
COUNCIL (RDC), NEDA, PALO, LEYTE";

WHEREAS, the Honorable City Mayor Eufrocino M. Codilla, Sr.,
through 1st Indorsement dated 7 December 1999, endorsed to the Secretary
to the Sangguniang Panlungsod ng Ormoc CDC Resolution No. 03 s. 1999 for
appropriate legislative action;

WHEREAS, said Resolution No. 3 s. 1999 has stated that the Local
Government Code of 1991 asserts that "each local government unit shall
have a comprehensive multi-sectoral investment plan" and that the same
is formulated by the City Planning and Development Office in
coordination with all barangay chairmen, local and line agencies;

WHEREAS, after thorough discussion, this august Body has found out
that said plan is within the development thrust of the city;



WHEREFORE, foregoing premises considered, on motion of City Councilor Claudio P. Larrazabal, Chairman, Committee on Infrastructures, jointly seconded by City Councilors Alfredo F. Capahi and Chiqui B. Labagala; be it
