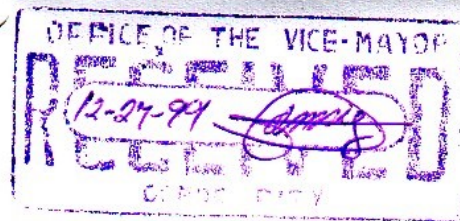
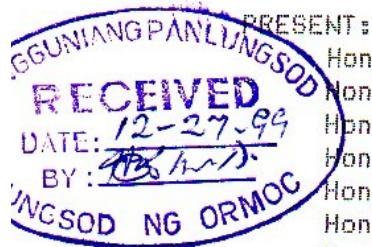


ADOPTED, December 23, 1999.


