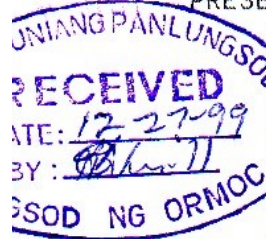

DECEMBER 30 IS A HOLIDAY BEING RIZAL DAY;



concerned, in Ormoc City;


