A RESOLUTION AUTHORIZING THE HONORABLE CITY EUFROCINO M. CODILLA, SR., TO ENTER INTO AND SIGN, FOR IN BEHALF OF THE CITY GOVERNMENT OF ORMOC, A MEMORANDUM OF AGREEMENT WITH THE DEPARTMENT OF ENVIRONMENT AND NATURAL RESOURCES (DENR) REPRESENTED BY ITS \ FROVINCIAL ENVIRONMENT AND NATURAL (PENRO) FELIPE S. CALUB, CESO V, FOR THE OFFICER IMPLEMENTATION OF THE COMMUNITY BASED FOREST MANAGEMENT (DBFM) PROJECT IN BARANGAYS NAUNGAN AND SAN JUAN, ORMOC CITY.

wHEREAS, this Sanggunian is in receipt of 3rd Indorsement dated 08 December 1999 from the Honorable City Mayor, Eufrocino M. Codilla, Sr., Memorandum of Agreement in the creation of Support Groups for the implementation of Community Based Forest Management (CBFM) Project in Barangay Naungan and San Juan, this city between DENR and the City Government of Ormoc with a request for a passage of a resolution authorizing the Honorable City Mayor to sign said MOA for and in behalf of the City Government of Ormoc;

WHEREAS, said Memorandum of Agreement mentions of the need for the action involvement of the City Government of Ormoc in the implementation of Community-Based Forest Management Program within its jurisdiction considering that the DENR has devolved projects and other forest management functions to Local Government Units;

WHEREAS, the City Legal Officer through 2nd Indorsement dated November 1999 has stated that "the signing of this MOA will beneficial to the City of Ormoc as this will spur the consciousness active participation of the City of Ormoc and its residents in sustainable management and development of its forest resources";
