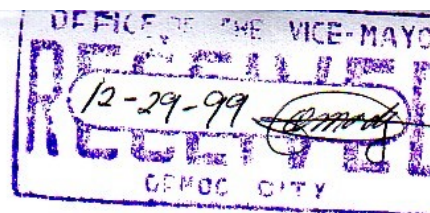

A RESOLUTION AUTHORIZING THE HONORABLE CITY MAYOR
EUFROCINO M. CODILLA, SR., TO ENTER INTO AND SIGN, FOR
AND IN BEHALF OF THE CITY GOVERNMENT OF ORMOC, A
MEMORANDUM OF AGREEMENT WITH THE DEPARTMENT OF
ENVIRONMENT AND NATURAL RESOURCES (DENR) REPRESENTED BY
ITS PROVINCIAL ENVIRONMENT AND NATURAL RESOURCES
OFFICER (PENRO) FELIPE S. CALUB, CESO V, FOR THE
IMPLEMENTATION OF THE COMMUNITY BASED FOREST MANAGEMENT
(CBFM) PROJECT IN BARANGAYS NAUNGAN AND SAN JUAN, ORMOC
CITY.

WHEREAS, this Sanggunian is in receipt of 3rd Indorsement dated 08
December 1999 from the Honorable City Mayor, Eufrocino M. Codilla, Sr.,
re: Memorandum of Agreement in the creation of Support Groups for the
implementation of Community Based Forest Management (CBFM) Project in
Barangay Naungan and San Juan, this city between DENR and the City
Government of Ormoc with a request for a passage of a resolution
authorizing the Honorable City Mayor to sign said MOA for and in behalf
of the City Government of Ormoc;

WHEREAS, said Memorandum of Agreement mentions of the need for the
action involvement of the City Government of Ormoc in the implementation
of Community-Based Forest Management Program within its jurisdiction
considering that the DENR has devolved projects and other forest
management functions to Local Government Units;

WHEREAS, the City Legal Officer through 2nd Indorsement dated 29
November 1999 has stated that "the signing of this MOA will be
beneficial to the City of Ormoc as this will spur the consciousness and
active participation of the City of Ormoc and its residents in the
sustainable management and development of its forest resources";

WHEREFORE, foregoing premises considered, on motion of City Councilor Jose C. Alfaro, Jr., Chairman, Committee on Natural Resources and Environment Control, severally seconded by City Councilors Mariano Y. Corro, Dennis Y. Capuyan and Chiqui B. Labagala; be it

RESOLVED, AS IT IS HEREBY RESOLVED, to pass a resolution AUTHORIZING THE HONORABLE CITY MAYOR EUFROCINO M.
