

RESOLUTION APPROVING RESOLUTION NO. 5 SERIES OF 1999 OF EXECUTIVE COMMITTEE, CITY DEVELOPMENT COUNCIL, ENTITIND: "A RESOLUTION APPROVING THE REALIGNMENT OF CONSTRUCTION OF BASKETBALL COURT & STAGE OF VALENCIA IN THE AMOUNT OF FOUR HUNDRED THOUSAND PESOS №400,000.00) UNDER THE 1998 CEO FUND TO THE BARANGAY ROAD OPENING AT BRGY. BAGONG IN THE SAME AMOUNT AND REQUESTING THE HONORABLE SANGGUNIANG PANLUNGSOD FOR THE APPROVAL OF THE SAME."

WHEREAS, this Sanggunian is in receipt of a copy of CDC Executive Committee Resolution No. 05 s. 1999, entitled: "A RESOLUTION APPROVING THE REALIGNMENT OF CONSTRUCTION OF BASKETBALL COURT & STAGE OF BRGY.
