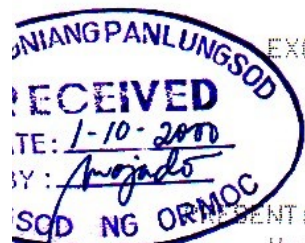

RESOLUTION NO. 2000-001

A RESOLUTION AUTHORIZING THE HONORABLE CITY MAYOR
EUFROCINO M. CODILLA, SR., TO ENTER INTO AND SIGN, FOR
AND IN BEHALF OF THE CITY GOVERNMENT OF ORMOC, A
MEMORANDUM OF AGREEMENT WITH THE DEPARTMENT OF SOCIAL
WELFARE AND DEVELOPMENT FIELD OFFICE VIII REPRESENTED
BY THE REGIONAL DIRECTOR, MISS AIDA A. DOMINGO FOR THE
TRANSFER OF OPERATION OF THE LINGAP CENTER FROM DSWD TO
THE LOCAL GOVERNMENT OF ORMOC CITY.

WHEREAS, this august Body is in receipt of 1st Indorsement dated 23
December 1999 from the Honorable City Mayor Eufrocino M. Codilla, Sr.,
requesting for a passage of a resolution authorizing him to sign for and
in behalf of the City Government of Ormoc the Memorandum of Agreement
(MOA) between the Department of Social Welfare and Development, Field
Office VIII and the Local Government of Ormoc for operation of Lingap
Center;

WHEREAS, said Memorandum of Agreement (MOA) mentions that
Department of Social Welfare and Development is the welfare arm of the
government and is mandated to provide among others, care, protection and
rehabilitation of children and youth who are abandoned, neglected,
abused and exploited and that the Local Government of Ormoc City is
administratively capable to take over the operation of Lingap Center
from DSWD;

WHEREAS, this august Body has considered said request reasonable
and beneficial, hence, same be accorded due course of action;

WHEREFORE, on motion of Councilor Dennis Y. Capuyan, Chairman, Committee on Health, Public & Social Welfare, severally seconded by Councilors Sotero M. Pepito, Mariano Y. Corro & Eduardo P. Tan; be it

RESOLVED, AS IT IS HEREBY RESOLVED, to pass a resolution AUTHORIZING THE HONORABLE CITY MAYOR EUFROCINO M. CODILLA, SR., TO ENTER INTO AND SIGN, FOR AND IN BEHALF OF THE CITY GOVERNMENT OF ORMOC, A MEMORANDUM OF AGREEMENT WITH THE DEPARTMENT OF SOCIAL WELFARE AND DEVELOPMENT FIELD OFFICE VIII REPRESENTED BY THE REGIONAL DIRECTOR, MISS AIDA A. DOMINGO FOR THE TRANSFER OF OPERATION OF THE LINGAP CENTER FROM DSWD TO THE LOCAL GOVERNMENT OF ORMOC CITY;
