


RESOLUTION NO. 2000-002

A RESOLUTION SUPPORTING RESOLUTION NO. 99-261 OF THE  
SANGGUNIANG PANLUNGSOD NG TACLOBAN ENTITLED: "A  
RESOLUTION REQUESTING THE CHAIRMAN OF THE REGIONAL  
DEVELOPMENT COUNCIL, HONORABLE CITY MAYOR, ALFREDO T.  
ROMUALDEZ, TO ESTABLISH A REGIONAL MENTAL HEALTH  
CENTER.

WHEREAS, the Sanggunian is in receipt of 1st Indorsement dated 27  
December 1999 from the Office of the City Mayor requesting for the  
passage of a resolution supporting Resolution No. 99-261 of the  
Sangguniang Panlungsod ng Tacloban entitled: "A RESOLUTION REQUESTING  
THE CHAIRMAN OF THE REGIONAL DEVELOPMENT COUNCIL HONORABLE CITY MAYOR,  
ALFREDO T. ROMUALDEZ, TO ESTABLISH A REGIONAL MENTAL HEALTH CENTER";

WHEREAS, said resolution has stated that "there should be an  
institution for them to show to the world that love is more intense for  
those needing greater attention" and that "since they are our people -  
our brothers and sisters, local government units of Region 8 are morally  
obliged to make a joint effort to solve this concern";

WHEREAS, in the resolved portion of Resolution No. 99-261 of the  
Sangguniang Panlungsod ng Tacloban, it requests that "local government  
units of Region VIII to allocate funds in their Annual Budgets for the  
establishment and maintenance of a Regional Mental Health Center", it is  
suggested by this august Body that local government units shall also  
mean to include the Provincial Governments;

WHEREAS, the Sangguniang Panlungsod ng Ormoc, mindful of the  
benefits that will be derived therefrom has considered said request  
reasonable, hence, be given due course of action;
