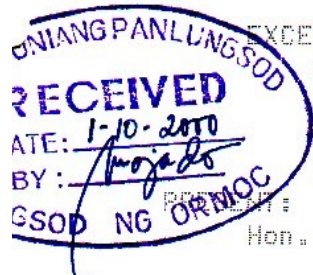
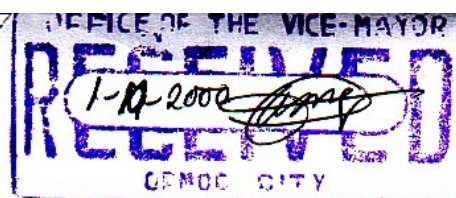

RESOLUTION NO. 2000-003

A RESOLUTION REORGANIZING THE COMPOSITION OF THE
COMMITTEES: (1) GOOD GOVERNMENT, ETHICS & HUMAN RIGHTS;
(2) MANPOWER DEVELOPMENT; (3) ZONING & BEAUTIFICATION;
and (4) COTTAGE INDUSTRY & COOPERATIVES.

WHEREAS, the INTERNAL RULES OF PROCEDURE of this Sanggunian,
specifically Rule IV, Section 6 thereof, provides:

"TENURE OF OFFICE OF COMMITTEE CHAIRMAN AND MEMBERS -
The Committee Chairman and Members as organized and approved
by this Body shall be subject to change only upon proper
resolution duly adopted and approved by the Sanggunian."

WHEREAS, it is the sense of the members of this august body that
the composition of the following committees be reorganized, to wit: 1)
GOOD GOVERNMENT, ETHICS & HUMAN RIGHTS; 2) MANPOWER DEVELOPMENT; 3)
ZONING & BEAUTIFICATION; and 4) COTTAGE INDUSTRY & COOPERATIVES.

WHEREAS, for record purposes, let it be known that the Chairman of
the above-mentioned committees has changed his party affiliation to
Lapiang Masang Pilipino, and is relegated to a Minority Floor Leader;
and as such, it is now incumbent upon the Majority to change the
Chairmanship of the Committees formerly under him;
