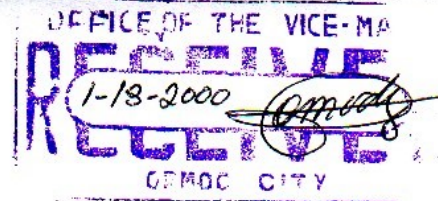
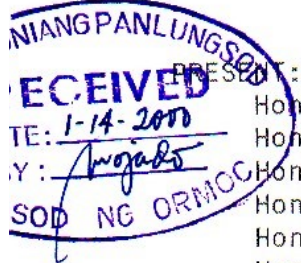

Councilor Alfredo F. Capahi; be it


RESOLVED, to pass a resolution APPROVING THE ANNUAL BUDGETS FOR CY

ADOPTED, January 13, 2000.


RESOLVED, FURTHER, to furnish copies of this resolution each to His
