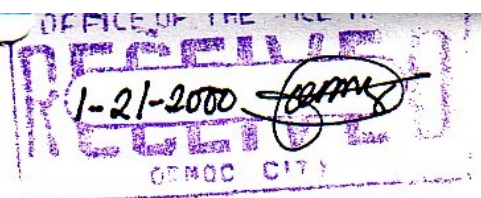
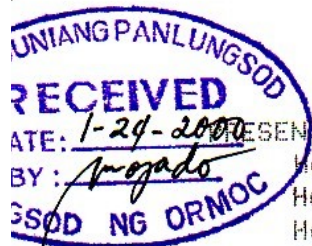

Claudio P. Larrazabal, Alfredo F. Capahi and Fernando P. Parrilla; be it


RESOLVED, AS IT IS HEREBY RESOLVED, to pass a resolution FAVORABLY
