RESOLUTION NO. 2000-010

A RESOLUTION REQUESTING MARITIME INDUSTRY AUTHORITY  
(MARINA) TO ACT FAVORABLY ON THE PETITION OF OCEAN JET  
(OR ANY OTHER FAST CRAFT COMPANY) TO SERVICE THE ROUTE  
BETWEEN ORMOC AND CEBU AND VICE VERSA.

WHEREAS, Ormoc City, the gateway of Region 8 to most part of the  
country as far as sea travel is concerned, is a growing City; and that  
Region 8, once a sleepy region is now moving ahead to meet the  
challenges of the new millennium;

WHEREAS, the City of Ormoc and the neighboring municipality of  
Kananga are the major electric power sources of the Philippines so that  
many entrepreneurs come to these places;

WHEREAS, records of the Philippine Ports Authority show that in  
1997 to 1999 there was an average daily passage of about 3000 passengers  
and unfortunately however, with the stoppage of the operation of Water  
Jet and with the reduction of the number of trips by Super Cat, the  
convenience and travel access of the commuters have been greatly  
jeopardized;

WHEREFORE, foregoing premises considered, on motion of City  
Councilor Jose C. Alfaro, Jr., jointly seconded by City Councilors Dennis  
Y. Capuyan and Claudio P. Larrazabal; be it

RESOLVED, AS IT IS HEREBY RESOLVED, to pass a resolution REQUESTING  
MARITIME INDUSTRY AUTHORITY (MARINA) TO ACT FAVORABLY ON THE PETITION OF  
OCEAN JET (OR ANY OTHER FAST CRAFT COMPANY) TO SERVICE THE ROUTE BETWEEN  
ORMOC AND CEBU AND VICE VERSA;
