ROAD CONCRETING IN THE AMOUNT OF FIVE HUNDRED THOUSAND  
PESOS (P500,000.00) TO COMPLETION OF WATER SUPPLY  
SYSTEM OF THE SAME BARANGAY IN THE AMOUNT OF FIVE  
HUNDRED THOUSAND PESOS (P500,000.00) AND REQUESTING THE  
HONORABLE SANGGUNIANG PANLUNGSOD FOR THE APPROVAL OF

WHEREAS, this Sanggunian is in receipt of a copy of CDC Executive
