A RESOLUTION AUTHORIZING THE CITY ACCOUNTANT TO CHARGE TO CURRENT APPROPRIATION FOR OTHER SERVICES OF SANGONNIANG PANLUNGSOD THE AMOUNT OF SIX THOUSAND PESOS § 00/100 (№6,000.00) REPRESENTING THE UNPAID BILL OF THE SOLID WASTE MANAGEMENT TEAM (SWMT) WITH ANYAS NOOK DATED 12 DÉCEMBER 1998.

WHEREAS, this Sanggunian is in receipt of a Billing Statement dated to January 2000 from Mrs. Irma D. Paras, owner, Anyas Nook addressed to the Honorable City Vice Mayor Celso P. Adolfo in the amount of SIX THOUSAND PESOS 00/100 (P6,000.00) for the payment of meals and snacks during the Solid Waste Management Team (SWMT) meeting held last December 12, 1998;
