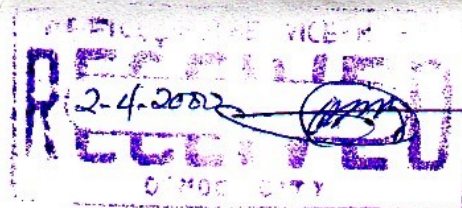
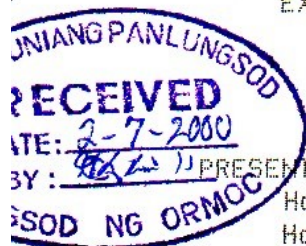

RESOLUTION NO. 2000-013

A RESOLUTION AUTHORIZING THE CITY ACCOUNTANT TO CHARGE TO CURRENT APPROPRIATION FOR OTHER SERVICES OF THE SANGGUNIANG PANLUNGSOD THE AMOUNT OF SIX THOUSAND PESOS & 00/100 (P6,000.00) REPRESENTING THE UNPAID BILL OF THE SOLID WASTE MANAGEMENT TEAM (SWMT) WITH ANYAS NOOK DATED 12 DECEMBER 1998.

WHEREAS, this Sanggunian is in receipt of a Billing Statement dated 10 January 2000 from Mrs. Irma D. Paras, owner, Anyas Nook addressed to the Honorable City Vice Mayor Celso P. Adolfo in the amount of SIX THOUSAND PESOS 00/100 (P6,000.00) for the payment of meals and snacks during the Solid Waste Management Team (SWMT) meeting held last December 12, 1998;

WHEREAS, the City Budget Officer through 3rd Indorsement dated 27 January 2000 reiterated that authority be granted to the City Accountant to charge above obligations against current appropriation for other services;

WHEREAS, Mrs. Salud A. Rivera, ICO - City Treasurer, through 5th Indorsement dated 28 January 2000 has certified that fund is available subject however to accounting and auditing rules and procedures;
