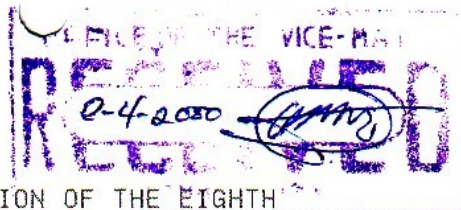
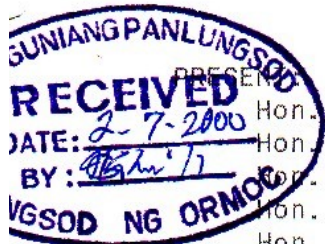

RESOLUTION NO. 2000-015

A RESOLUTION APPROVING BARANGAY TAX ORDINANCE NO. 001-2000 OF BARANGAY PUNTA, THIS CITY, ENTITLED: "AN ORDINANCE IMPOSING TAXES OF (SIC) RETAILERS, BILLBOARDS, SIGNBOARDS, BARANGAY CLEARANCES, AND BARANGAY PERMIT" WITH A RECOMMENDATION THAT PAR. 2 OF SEC. 8 WHICH REFERS TO MARRIAGE LICENSE BE CORRECTED AND IT SHOULD APPEAR AS MARRIAGE CLEARANCE.

WHEREAS, this Sanggunian is in receipt of Barangay Tax Ordinance No. 001-2000 of Barangay Punta, this city, entitled: "AN ORDINANCE IMPOSING TAXES OF (SIC) RETAILERS, BILLBOARDS, SIGNBOARDS, BARANGAY CLEARANCES, AND BARANGAY PERMITS";

WHEREAS, the Sangguniang Panlungsod ng Ormoc, in relation to the aforecited ordinance at issue (and all other ordinances of the Sangguniang Barangay in Ormoc City), is by law, granted the Power of Review as to whether the said ordinance is consistent with law and city X X ordinances; (Sec. 57, 1991 LGC);

WHEREAS, it is the observation of this august Body that the aforesaid ordinance has conformed to pertinent provisions of the Local Government Code, hence, reasonable and within the province of the Sangguniang Barangay of Punta to legislate;

WHEREFORE, foregoing premises considered, on motion of City Councilor Nepomuceno P. Aparis I, Chairman, Committee on Laws and Ordinances, jointly seconded by City Councilors Dennis Y. Capuyan and Alfredo F. Capahi; be it

RESOLVED, AS IT IS HEREBY RESOLVED, to pass a resolution APPROVING BARANGAY TAX ORDINANCE NO. 001-2000 OF BARANGAY PUNTA, THIS CITY, ENTITLED: "AN ORDINANCE IMPOSING TAXES OF (SIC) RETAILERS, BILLBOARDS, SIGNBOARDS, BARANGAY CLEARANCES, AND BARANGAY PERMIT" WITH A RECOMMENDATION THAT PAR. 2 OF SEC. 8 WHICH REFERS TO MARRIAGE LICENSE BE CORRECTED AND IT SHOULD APPEAR AS MARRIAGE CLEARANCE;
