A RESOLUTION AUTHORIZING THE HONORABLE CITY MAYOR  
EUFROCINO M. CODILLA, SR., TO ENTER INTO AND SIGN, FOR  
AND IN BEHALF OF THE CITY GOVERNMENT OF ORMOC, A  
CONTRACT FOR MATERIAL AND SERVICES, WITH UNIFARM  
MULTIPURPOSE COOPERATIVE, INC., FOR THE FABRICATION AND  
INSTALLATION OF HOUSE NUMBER PLATES.

WHEREAS, this august Body is in receipt of 3rd Indorsement dated 15  
December 1999 from the Honorable City Mayor Eufrocino M. Codilla, Sr.,  
requesting for a passage of a resolution authorizing him to sign for an  
in behalf of the City Government of Ormoc, a contract for materials and  
services with UNIFARM MULTIPURPOSE COOPERATIVE, INC., for the  
fabrication and installation of house number plates;

WHEREAS, the City Legal Officer through 2nd Indorsement dated 9
