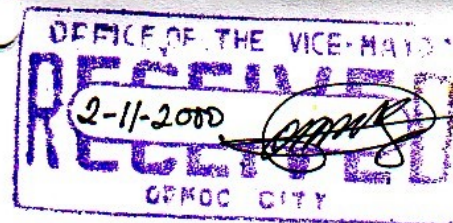

A RESOLUTION AUTHORIZING THE HONORABLE CITY MAYOR
EUFROCINO M. CODILLA, SR., TO SIGN FOR AND IN BEHALF OF
THE CITY GOVERNMENT OF ORMOC TWO (2) DEEDS OF ABSOLUTE
SALE FOR THE PURCHASE OF THE FOLLOWING LOTS:

- A) LOT NO. 6225-G-11 COVERED BY T.C.T. NO. 35575
OWNED BY MS. JOSEFINA MARTINEZ DE CORDOVA
CONTAINING AN AREA OF FORTY TWO THOUSAND NINE
HUNDRED ELEVEN (42,911) SQ. METERS LOCATED AT
BARANGAY CURVA, ORMOC CITY.
- B) LOT NO. 6225-F-15 COVERED BY T.C.T. NO. 35520
CONTAINING AN AREA OF EIGHTEEN THOUSAND TWO
HUNDRED FORTY TWO (18,242) SQ. METERS AND LOT NO.
6225-F-15-C COVERED BY T.C.T. NO. 35519 CONTAINING
AN AREA OF THREE HUNDRED SEVENTY SEVEN (377) SQ.
METERS OWNED BY RICHARD RAYMOND L. CORDOVA LOCATED
AT BARANGAY CURVA, THIS CITY, TO BE USED AS
ADDITIONAL RELOCATION SITE FOR FAMILIES AFFECTED
BY FLOOD MITIGATION PROJECT OF THE CITY GOVERNMENT
OF ORMOC.

WHEREAS, this august Body is in receipt of a letter dated 25
January 2000 from the Honorable City Mayor Eufrocino M. Codilla, Sr.,
requesting for passage of a resolution authorizing him to sign the two
(2) Deeds of Absolute Sale for the additional relocation site of
families affected by the JICA Flood Mitigation Project Phase II;

WHEREAS, one of the obligations of the City Government of Ormoc under the Joint Memorandum of Agreement for the implementation of JICA Flood Mitigation Project is to purchase and develop the resettlement area for the affected families including basic infrastructure needs such as access roads, interval roads, drainage system, water supply, school buildings, health, city lighting and livelihood projects;

WHEREAS, this august Body has considered said request valid and reasonable, hence, the same be accorded due course of action;

WHEREFORE, foregoing premises considered, on motion of City Councilor Mariano Y. Corro, Chairman, Committee on Public Properties, jointly seconded by City Councilor Claudio P. Larrazabal and Alfredo F. Capahi; be it

RESOLVED, AS IT IS HEREBY RESOLVED, to pass a resolution AUTHORIZING THE HONORABLE CITY MAYOR EUFROCINO M. CODILLA, SR., TO SIGN FOR AND IN BEHALF OF THE CITY GOVERNMENT OF ORMOC TWO (2) DEEDS OF ABSOLUTE SALE FOR THE PURCHASE OF THE FOLLOWING LOTS:

- A) LOT NO. 6225-G-11 COVERED BY T.C.T. NO. 35575 OWNED BY MS. JOSEFINA MARTINEZ DE CORDOVA CONTAINING AN AREA OF FORTY TWO THOUSAND NINE HUNDRED ELEVEN (42,911) SQ. METERS LOCATED AT BARANGAY CURVA, ORMOC CITY.
- B) LOT NO. 6225-F-15 COVERED BY T.C.T. NO. 35520 CONTAINING AN AREA OF EIGHTEEN THOUSAND TWO HUNDRED FORTY TWO (18,242) SQ. METERS AND LOT NO. 6225-F-15-C COVERED BY T.C.T. NO. 35519 CONTAINING AN AREA OF THREE HUNDRED SEVENTY SEVEN (377) SQ. METERS OWNED BY RICHARD RAYMOND L. CORDOVA LOCATED AT BARANGAY CURVA, THIS CITY, TO BE USED AS ADDITIONAL RELOCATION SITE FOR FAMILIES AFFECTED BY FLOOD MITIGATION PROJECT OF THE CITY GOVERNMENT OF ORMOC.
