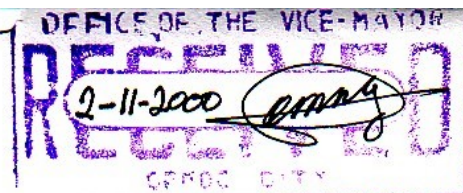

RESOLUTION NO. 2000-023

A RESOLUTION WAIVING THE CONDITION EMBODIED IN RESOLUTION NO. 96-17 DATED FEBRUARY 1, 1996 OF THIS SANGGUNIAN, COPY OF WHICH HERETO ATTACHED FOR READY REFERENCE, ANENT THE CONSTRUCTION OF THE BUILDING WITHIN ONE (1) YEAR FROM THE DATE OF THE EXECUTION OF THE DEED OF DONATION, THEREBY EXPRESSLY ALLOWING THE LAND REGISTRATION AUTHORITY TO CONSTRUCT THEIR BUILDING ON THE DONATED PROPERTY DESPITE THE LAPSE OF TIME MENTIONED IN RESOLUTION NO. 96-17, PROVIDED, THAT THE CONSTRUCTION THEREOF SHALL COMMENCE WITHIN ONE YEAR FROM TIME OF ADOPTION OF THIS RESOLUTION.

WHEREAS, on February 9, 2000 this Sanggunian received an URGENT indorsement dated February 8, 2000 from the Honorable City Mayor Eufrocino M. Codilla, Sr., requesting for the passage by this Sanggunian of a resolution waiving the time limitation for the construction of the building of the Land Registration Authority, imposed in Resolution No. 96-17 of this Sanggunian, which aforementioned indorsement is in conjunction with the letter dated February 8, 2000 addressed to this Sanggunian through the Honorable City Mayor of the Register of Deeds for Ormoc City, Atty. Arturo P. Suarez, copies of both aforecited indorsement and letter are hereto attached for ready reference;

WHEREAS, it is the sense of the members of this Sanggunian that the aforestated request is fair, reasonable and equitable considering the reasons stated in the attached letter of Atty. Suarez, hence will be acted favorably;

WHEREAS, this particular matter could not be discussed during the pre-session caucus last February 7, 2000 and therefore not included in today's Agenda for the apparent reason that the request for the passage of the desired resolution was only received on February 9, 2000 by this Sanggunian, but nevertheless considered in this session today, in view

of the URGENCY as certified to by the Honorable City Mayor for the passage of the desired resolution, and moreover, Article 107, par. (e) of the RRIOGC, provides:

"Any legislative matter duly certified by the local chief executive as urgent, whether or not it is included in the calendar of business, may be presented and considered by the body at the same meeting without need of suspending the rules."

WHEREFORE, premises considered, on motion of the Chairman, Committee on Public Properties, Councilor Mariano Y. Corro, jointly seconded by Councilors Nepomuceno P. Aparis I and Claudio P. Larrazabal; be it -

RESOLVED, AS IT IS HEREBY RESOLVED, to pass a resolution WAIVING THE CONDITION EMBODIED IN RESOLUTION NO. 96-17 DATED FEBRUARY 1, 1996 OF THIS SANGGUNIAN, COPY OF WHICH HERETO ATTACHED FOR READY REFERENCE, ANENT THE CONSTRUCTION OF THE BUILDING WITHIN ONE (1) YEAR FROM THE DATE OF THE EXECUTION OF THE DEED OF DONATION, THEREBY EXPRESSLY ALLOWING THE LAND REGISTRATION AUTHORITY TO CONSTRUCT THEIR BUILDING ON THE DONATED PROPERTY DESPITE THE LAPSE OF TIME MENTIONED IN RESOLUTION NO. 96-17, PROVIDED, THAT THE CONSTRUCTION THEREOF SHALL COMMENCE WITHIN ONE YEAR FROM TIME OF ADOPTION OF THIS RESOLUTION;
