## RESOLUTION NO. 2000-025

A RESOLUTION AUTHORIZING THE HONORABLE CITY MAYOR EURROCIND W. CODILLA, SR. TO SIGN, FOR AND IN BEHALF OF THE CITY GOVERNMENT OF ORMOC A MEMORANDUM OF AGREEMENT WITH THE NATIONAL HOUSING AUTHORITY REGARDING THE PROGRAM FOR THE 100 POOREST FAMILIES UNDER THE LINGAP PARM SA MAHIRAP.

WHEREAS, this Sanggunian is in receipt of 1st Indorsement dated 23 December 1979 from the Honorable City Mayor, Eufrocino M. Codilla, Sr., requesting for the passage of a Resolution authorizing him to sign for and in behalf of the City Government of Ormoc a Memorandum of Agreement (MCA) with the National Housing Authority regarding the Program for the 100 Poorest Families under the Lingap para sa Mahirap;

WHEREAS, said Memorandum of Agreement mentions of the provision of Executive Order No. 92 dated 12 April 1999 which mandated all Lingap Implementing Agencies to target the 100 poorest families per province and city identified by the Local Government Units (LGU's) as priority beneficiaries for the Socialized Housing Program under the Lingap para sa Mahirap with the National Housing Authority as the implementing agency;

WHEREAS, the Sangguniang Panlungsod ng Ormoc has considered said request reasonable, hence, same be accorded with the necessary course of action;

WHEREFORE, premises considered, on motion of City Councilor Eduardo P. Tan, Chairman, Committee on Urban Development, jointly seconded by City Councilors Dennis Y. Capuyan and Sotero M. Pepito; be it
