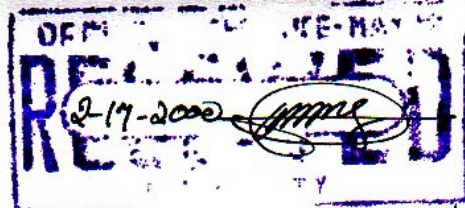

A RESOLUTION APPROVING BARANGAY ORDINANCE NO. 2000-002 OF
BARANGAY COGON, ENTITLED: "AN ORDINANCE AMENDING SOME
PROVISIONS OF BARANGAY ORDINANCE NO. 001, SERIES OF
1992 - "AN ORDINANCE PRESCRIBING THE RATES ON THE
ISSUANCE OF BARANGAY CLEARANCES AND OTHER CERTIFICATES,
PERMITS AND OTHER CHARGES".

WHEREAS, this Sanggunian is in receipt of Barangay Ordinance No.
2000-002 of Barangay Cogon, this city, entitled: "AN ORDINANCE AMENDING
SOME PROVISIONS OF BARANGAY ORDINANCE NO. 001, SERIES OF 1992 - "AN
ORDINANCE PRESCRIBING THE RATES ON THE ISSUANCE OF CLEARANCES AND OTHER
CERTIFICATES, PERMITS AND OTHER CHARGES";

WHEREAS, the Sangguniang Panlungsod ng Ormoc, in relation to the
