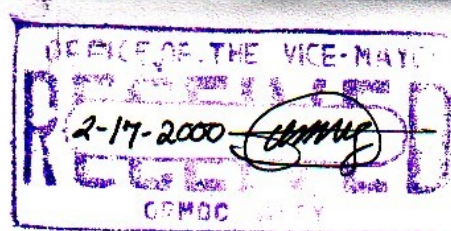

NO. 01 CY 2000 OF BARANGAY MAS-IN, THIS CITY;


ADOPTED, February 16, 2000.

Chairman/Treasurer of Barangay Mas-in, -all in Ormoc City;


