A RESOLUTION REORGANIZING THE MEMBERSHIP OF THE COMMITTEE PEOPLE'S ACCREDITATION OF COMMUNITY BASED ORGANIZATIONS (FOs), NGOs, INCLUDING BUSINESS PROFESSIONAL GROUPS AND OTHER SIMILAR AGGRUPATIONS FOR MEMBERSHIP IN THE LOCAL SPECIAL BODIES AS PROVIDED FOR IN ARTICLS 64 OF THE RULES AND REGULATIONS IMPLEMENTING THE LOCAL GOVERNMENT CODE OF 1991.

WHEREAS, Local Government Units (LGUs) are mandated by law on promoting the establishment and operation of People's Organizations (POs), (NGOs), and the private sector, to make them active partners in pursuit of local autonomy; hence, their membership to the Local Special Bodies in government is encouraged through accreditation, for them to be directly involved in the plans, programs and activities of the LGUs, (Article 62 RRILGC);
