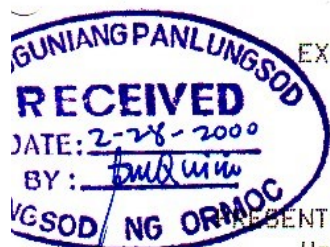
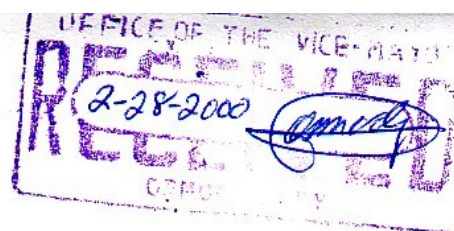

RESOLUTION NO. 2000-033

A RESOLUTION EXTENDING THE DEADLINE FOR RENEWAL OF THE
CITY LICENSES/MAYOR'S PERMITS OF BUSINESS FROM FEBRUARY
29, 2000 TO MARCH 31, 2000.

WHEREAS, this Sanggunian is in receipt of 1st Indorsement dated 23
February 2000 re: Letter of Mr. Melchor Sia, President, Ormoc Filipino
Retailer Association (OFRA), Inc., requesting for another extension of
the deadline for the renewal of the City Licenses/Mayor's Permit from
February 29, 2000 to March 31, 2000;

WHEREAS, quoted hereunder is Art. 255 of the Implementing Rules and
Regulations of the Local Government Code which provides:

"Art. 255. Time of Payment - Unless otherwise
specifically provided in this Rule, all local taxes, fees,
and charges due and accruing to the LGUs shall be paid
within the first twenty (20) days of January or of each
subsequent quarter, as the case may be. The sanggunian
concerned may, for a justifiable reason or cause, extend the
time for payment of such taxes, fees, or charges without
surcharges or penalties, but only for a period not exceeding
six (6) months."

WHEREAS, this august Body through the Honorable Chairman, Committee
on Finance has considered said request reasonable in view of the reasons
stated therein;

WHEREFORE, foregoing premises considered, on motion of City
Councilor Alfredo F. Capahi, Chairman, Committee on Finance, jointly
seconded by City Councilors Nepomuceno P. Aparis I and Claudio P.
Larrazabal; be it

RESOLVED, AS IT IS HEREBY RESOLVED, to pass a resolution EXTENDING THE DEADLINE FOR RENEWAL OF THE CITY LICENSES/MAYOR'S PERMITS OF BUSINESS FROM FEBRUARY 29, 2000 TO MARCH 31, 2000;

ADOPTED, February 24, 2000.
