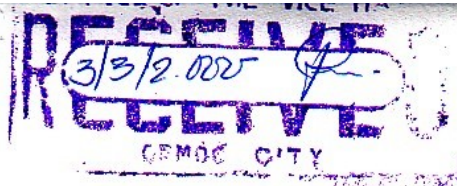
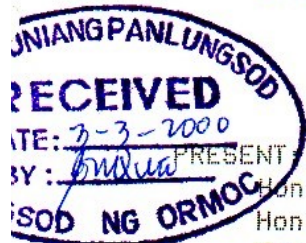

RESOLUTION NO. 2000-035

A RESOLUTION APPROVING BARANGAY ORDINANCE NO. 2000-002 S. 2000, OF BARANGAY DISTRICT XXIV, THIS CITY, ENTITLED: "AN ORDINANCE FIXING THE RATES OF BARANGAY CLEARANCE FEES, PERMITS, AND OTHER CHARGES AND FEES FOR THE AVAILMENT OF USE OF VARIOUS PROPERTIES AND SERVICES OF THE BARANGAY."

WHEREAS, this Sanggunian is in receipt of Barangay Ordinance No. 2000-002 series of 2000 of Barangay District XXIV, this city, entitled: "AN ORDINANCE FIXING THE RATES OF BARANGAY CLEARANCE FEES, PERMITS, AND OTHER CHARGES AND FEES FOR THE AVAILMENT OF USE OF VARIOUS PROPERTIES AND SERVICES OF THE BARANGAY;"

WHEREAS, the Sangguniang Panlungsod ng Ormoc, in relation to the aforesaid ordinance at issue (and all other ordinances of the Sangguniang Barangay in Ormoc City), is by law, granted the Power of Review as to whether the said ordinance is consistent with law and city ordinances, (Sec. 57, 1991 LGC);

WHEREAS, it is the observation of this august Body that the aforesaid ordinance has conformed to pertinent provisions of the local Government Code, hence, reasonable and within the province of the Sangguniang Barangay of Barangay District XXIV;

WHEREFORE, foregoing premises considered, on motion of City Councilor Nepomuceno P. Aparis I, Chairman, Committee on Laws and Ordinances, duly seconded by Councilor Sotero M. Pepito; be it
