## RESOLUTION NO. 2000-03

A RESOLUTION APPROVING BARANGAY ORDINANCE NO. 2000-002 S. 2000, OF BARANGAY DISTRICT XXIV, THIS CITY, ENTITLED: "AN ORDINANCE FIXING THE RATES OF BARANGAY CLEARANCE AND OTHER CHARGES AND FEES FOR THE FEES, FERMITS, AND OTHER CHARGES AND FEES FOR THE AVAILMENT OF USE OF VARIOUS PROPERTIES AND SERVICES OF THE BARANGAY."

WHEREAS, this Sanggunian is in receipt of Barangay Ordinance No. 2000-002 saries of 2000 of Barangay District XXIV, this city, entitled: "AN ORDINANCE FIXING THE RATES OF BARANGAY CLEARANCE FEES, PERMITS, AND OTHER CHARGES AND FEES FOR THE AVAILMENT OF USE OF VARIOUS PROPERTIES AND SERVICES OF THE BARANGAY;"
