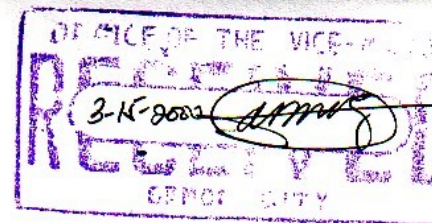
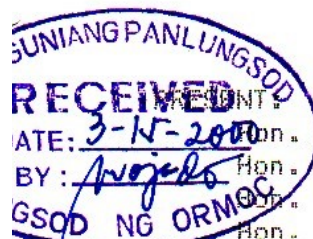

A RESOLUTION AFFIRMING THAT THE CONSTRUCTION OF A NEW
ORMOC CITY HALL AT THE GOVERNMENT CENTER, IS HIGHLY
NECESSARY.

WHEREAS, this august Body is in receipt of a letter dated 21
February 2000 from the Honorable City Mayor Eufrocino M. Codilla, Sr.,
the full text of which is hereunder cited as follows:

Attached is the Narrative Inspection Report dated
February 18, 2000 of Engr. Antonio Z. Padayao, City
Engineer, pertaining to the status of the present Ormoc City
Hall.

Based on his report, the Old City Hall Building is no
longer safe for employees and the public as well, since its
existing foundation was designed with wooden piles only,
having a limited liveload capacity, and is dangerous during
high intensity earthquakes.

In view of my desire to serve effectively the needs of the growing public who are transacting business at the City Hall, may I respectfully request the august Body to pass a resolution that the Construction of a New Ormoc City Hall at the Government Center, is highly necessary.

Your immediate favorable action on this request is highly appreciated.

WHEREAS, it can be recalled that SP Resolution No. 78-124 has approved City Development Council (CDC) Resolution No. 01 s. 1998 entitled: "A RESOLUTION APPROVING THE 1999 DEVELOPMENT PROJECTS AND PROGRAMS IN THE AMOUNT OF NINETY TWO MILLION PESOS ONLY (P92,000,000.00) AND REQUESTING THE HONORABLE SANGGUNIAN PANLUNGSOD NG ORMOC FOR THE APPROVAL OF THE SAME", wherein one of the projects for approval under the 20% Development Fund was the Construction of Ormoc City Hall and Convention Center (Phase I) in the amount of P14,912,600.00 and that under the CEO Projects (Building & Structure Outlay) the same is included, construction of Ormoc City Hall Bldg. and Convention Center (Phase I) in the amount of P15,087,402.00;

WHEREAS, this Sangguniang Panlungsod has considered said request reasonable and meritorious taking into consideration the Narrative Inspection Report submitted by the City Engineer regarding the old City Hall which was built way back in 1946 and is no longer safe for occupancy, hence, the same be accorded due course of action;

WHEREFORE, foregoing premises considered, on motion of City Councilor Claudio P. Larrazabal, Chairman, Committee on Infrastructure, severally seconded by City Councilors Nepomuceno P. Aparis I, Alfredo F. Capahi and Fernando P. Parrilla; be it

RESOLVED, AS IT IS HEREBY RESOLVED, to pass a resolution AFFIRMING THAT THE CONSTRUCTION OF A NEW ORMOC CITY HALL AT THE GOVERNMENT CENTER, IS HIGHLY NECESSARY;

ADOPTED, March 02, 2000.

RESOLVED, FURTHER, to furnish copies of this resolution each to His Honor, the City Mayor, the City Administrator, the City Treasurer, the City Budget Officer, the City Accountant, the City Auditor, the City Engineer, the CPDO and others concerned, - in Ormoc City;
