SONYALES, SECRETARY OF THE DEPARTMENT OF EDUCATION, CULTURE AND SPORTS (DECS) TO CONVERT MERIDA VOCATIONAL SCHOOL - MARGEN ANNEX SITUATED IN BARANGAY MARGEN, OTMOC CITY INTO MARGEN NATIONAL HIGH SCHOOL TO BE AN INDEPENDENT HIGH SCHOOL UNDER THE JURISDICTION OF THE DECS OTMOC CITY DIVISION.

WHEREAS, this august Body is in receipt of a letter dated 4 Fabruary 2000 from Dr. Violeta M. Alocilja, CESO VI, Schools Division Superintendent, Ormoc City Division, requesting for the passing of a resolution for the conversion of the Merida Vocational School - Margen Annex, into Margen National High School, an independent high school under the jurisdiction of the Ormoc City Division;

WHEREAS, as stated in said letter, the requested resolution is necessary supporting document to save Margen Annex and to meet the deadline of the DBM for purposes of inclusion into th budget under the General Appropriations Act for year 2001;

WHEREAS, this august Body believes that the request is reasonable considering that Merida-Vocational School - Margen Annex is actually located in Ormoc City which said school should be, for all intents and purposes, under the jurisdiction of the DECS, Ormoc City Division, hence, the same be given due course;
