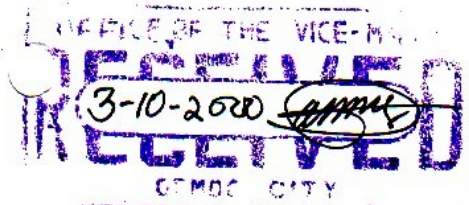

2000 OF BARANGAY CURVA AND BARANGAY NASUNOGAN, BOTH IN ORMOC CITY;


ADOPTED, March 09, 2000.

Ormoc City;


