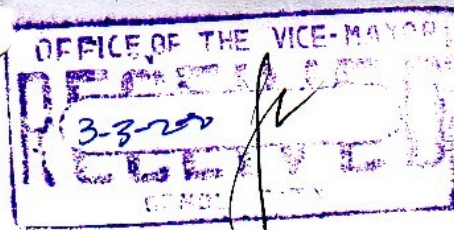
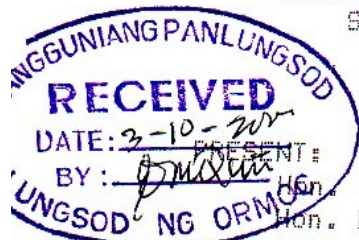

RESOLUTION NO. 2000-040

A RESOLUTION APPROVING BARANGAY ORDINANCE NO. 2000-002 OF  
BARANGAY LABRADOR, THIS CITY, ENTITLED: "AN ORDINANCE  
PROHIBITING RESIDENTS OF THIS BARANGAY FROM THE  
INDISCRIMINATE THROWING OF GARBAGE, AND/OR UNSANITARY  
DISPOSAL OF ANY WASTE MATERIALS, AND PROVIDING  
PENALTIES THEREOF."

WHEREAS, this Sanggunian is in receipt of Ordinance No. 2000-002 of  
the Barangay Labrador, this city, entitled: "AN ORDINANCE PROHIBITING  
RESIDENTS OF THIS BARANGAY FROM THE INDISCRIMINATE THROWING OF GARBAGE,  
AND/OR UNSANITARY DISPOSAL OF ANY WASTE MATERIALS, AND PROVIDING  
PENALTIES THEREOF;"

WHEREAS, the Sangguniang Panlungsod ng Ormoc, in relation to the  
aforecited ordinance at issue (and all other ordinances of the  
Sangguniang Barangay in Ormoc City), is by law, granted the Power of  
Review as to whether the said ordinance is consistent with law and city  
X X X ordinances; (Sec. 57, 1991 LGC)

WHEREAS, it is the observation of this august Body through the  
representation of the Honorable Chairman, Committee on Laws and  
Ordinances that the aforesaid ordinance has conformed to pertinent  
provisions of the Local Government Code, hence, reasonable and within  
the province of the Sangguniang Barangay of Brgy. Labrador to legislate;

Councilor Nepomuceno P. Aparis I, Chairman, Committee on Laws and  
Ordinances jointly seconded City Councilors Dennis Y. Capuyan and  
Claudio P. Larrazabal; be it


RESOLVED, to pass a resolution APPROVING BARANGAY ORDINANCE NO.
