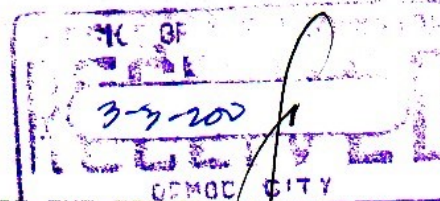
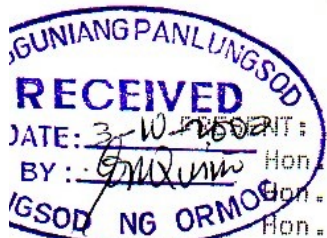

RESOLUTION NO. 2000-041

A RESOLUTION APPROVING BARANGAY ORDINANCE NO. 2000-003  
OF BARANGAY LABRADOR, THIS CITY, ENTITLED: "AN  
ORDINANCE PROHIBITING THE USE OF CHEMICALS AND OTHER  
POISONOUS SUBSTANCES FOR THE CATCHING OF FISH AND OTHER  
AQUATIC RESOURCES IN ALL WATERS WITHIN THE JURISDICTION  
OF THIS BARANGAY."

WHEREAS, this august Body is in receipt of Ordinance No. 2000-003  
of Barangay Labrador, this city, entitled: "AN ORDINANCE PROHIBITING THE  
USE OF CHEMICALS AND OTHER POISONOUS SUBSTANCES FOR THE CATCHING OF FISH  
AND OTHER AQUATIC RESOURCES IN ALL WATERS WITHIN THE JURISDICTION OF  
THIS BARANGAY;"

WHEREAS, the Sangguniang Panlungsod ng Ormoc, in relation to the  
aforecited ordinance at issue (and all other ordinances of the  
Sangguniang Barangay in Ormoc City), is by law, granted the Power of  
Review as to whether the said ordinance is consistent with law and city  
X X X ordinances; (Sec. 57, 1991 LGC)

WHEREAS, it is the observation of this august Body through the  
representation of the Honorable Chairman, Committee on Laws and  
Ordinances that the aforesaid ordinance has conformed to pertinent  
provisions of the Local Government Code, hence, reasonable and within  
the province of the Sangguniang Barangay of Brgy. Labrador to legislate;

WHEREFORE, foregoing premises considered, on motion of City  
Councilor Nepomuceno P. Aparis I, Chairman, Committee on Laws and  
Ordinances duly seconded City Councilor Claudio P. Larrazabal; be it

RESOLVED, to pass a resolution APPROVING BARANGAY ORDINANCE NO.  
2000-003 OF BARANGAY LABRADOR, THIS CITY, ENTITLED: "AN ORDINANCE  
PROHIBITING THE USE OF CHEMICALS AND OTHER POISONOUS SUBSTANCES FOR THE  
CATCHING OF FISH AND OTHER AQUATIC RESOURCES IN ALL WATERS WITHIN THE  
JURISDICTION OF THIS BARANGAY;"
