A RESOLUTION APPROVING BARANGAY ORDINANCE NO. 2000-003 BARANGAY LABRADOR, THIS CITY, ENTITLED: "AN MANCE PROHIBITING THE USE OF CHEMICALS AND OTHER POISONOUS SUBSTANCES FOR THE CATCHING OF FISH AND OTHER AQUATIC RESOURCES IN ALL WATERS WITHIN THE JURISDICTION OF THIS BARANGAY."

this august Body is in receipt of Ordinance No. 2000-003 of Barangay Labrador, this city, entitled: "AN ORDINANCE PROHIBITING THE USE OF CHEMICALS AND OTHER POISONOUS SUBSTANCES FOR THE CATCHING OF FISH AND OTHER AQUATIC RESOURCES IN ALL WATERS WITHIN THE JURISDICTION OF THIS BARANGAY:
