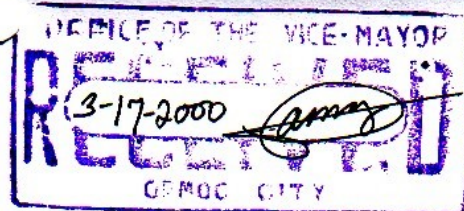

2000 OF BARANGAY BANTIGUE AND BARANGAY DISTRICT 26, BOTH IN ORMOC CITY;

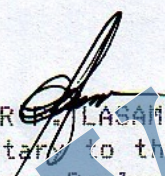
ADOPTED, March 16, 2000.

in Ormoc City;

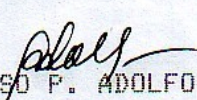
