

RESOLUTION NO. 2000-043

A RESOLUTION RETURNING TO BARANGAY CATMON, THIS CITY, THEIR ORDINANCE NO. 04 SERIES OF 2000, ENTITLED: "AN ORDINANCE AUTHORIZING AN INCREASE OF BARANGAY BUSINESS CLEARANCE AND OTHER FEES AND CHARGES", FOR THE REASON THAT THE FILING FEE FOR CASES FILED WITH THE LUPON TAGAPAMAYAPA SHOULD NOT EXCEED \$20.00 PER IMPLEMENTING RULES OF THE LUPON TAGAPAMAYAPA.

WHEREAS, this Sanggunian is in receipt of Ordinance No. 04 series of 2000 of Barangay Catmon, this city, entitled: "AN ORDINANCE AUTHORIZING AN INCREASE OF BARANGAY BUSINESS CLEARANCE AND OTHER FEES AND CHARGES", FOR THE REASON THAT THE FILING FEE FOR CASES THE LUPON TAGAPAMAYAPA SHOULD NOT EXCEED \$20.00 PER IMPLEMENTING RULES OF THE LUPON TAGAPAMAYAPA;

WHEREAS, this Sangguniang Panlungsod ng Ormoc is by law granted the Power of Review as to whether said Ordinance is consistent with law and city ordinances (Sec. 57, 1991, LGC);

WHEREAS, upon review of said Ordinance, it was found out that the amount of filing fee provided for cases filed with the Lupon Tagapamayapa is Thirty (\$30.00) Pesos;

WHEREAS, under the implementing rules and regulations on the operation of Lupon Tagapamayapa, the filing fee is not less than Five (\$5.00) Pesos but not to exceed Twenty (\$20.00) Pesos;

WHEREFORE, foregoing premises considered, on motion of City Councilor Nepomuceno P. Aparis I, Chairman on Laws and Ordinances, 'duly seconded by City Councilor Alfredo F. Capahi; be it
