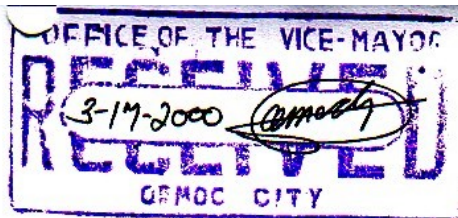

RESOLUTION NO. 2000-044

A RESOLUTION RETURNING TO THE BARANGAY COUNCIL OF CAMP
DOWNES, THIS CITY, THEIR BARANGAY ORDINANCE NO. 01
SERIES OF 2000, ENTITLED: " AN ORDINANCE IMPOSING TAXES
ON STORES OR RETAILERS, SIGNS, SIGNBOARDS AND
BILLBOARDS AND FOR OTHER PURPOSES", FOR THE REASON THAT
SAID ORDINANCE IS IN CONFLICT WITH SECTION 152
PARAGRAPH (A) OF THE LOCAL GOVERNMENT CODE OF 1991
FIXING THE TAX TO BE IMPOSED AT NOT MORE THAN ONE (1%)
PER CENT.

WHEREAS, this Sanggunian is in receipt of Ordinance No. 01 series
of 2000 of Barangay Camp Downes, this city, entitled: "AN ORDINANCE
IMPOSING TAXES ON STORES OR RETAILERS, SIGNS, SIGNBOARDS AND BILLBOARDS
AND FOR OTHER PURPOSES";

WHEREAS, this Sangguniang Panlungsod ng Ormoc is by law granted the
Power of Review as to whether said Ordinance is consistent with law and
city ordinance (Sec. 57, 1991, LGC);

WHEREAS, upon review of said Ordinance by this august Body, it was
found out that it is beyond the power of the Barangay Council of
Barangay Camp Downes to impose more than one percent (1%) taxation on
gross sales or receipts on stores or retailers with fixed business
establishment as provided in SEC. 152 (a) of the Local Government Code
of 1991;

WHEREFORE, foregoing premises considered, on motion of City
Councilor Nepomuceno P. Aparis I, Chairman, Committee on Laws and
Ordinances, jointly seconded by City Councilors Dennis Y. Capuyan and
Sotero M. Pepito; be it

RESOLVED, AS IT IS HEREBY RESOLVED, to pass a resolution RETURNING TO THE BARANGAY COUNCIL OF CAMP DOWNES, THIS CITY, THEIR BARANGAY ORDINANCE NO. 01 SERIES OF 2000, ENTITLED: " AN ORDINANCE IMPOSING TAXES ON STORES OR RETAILERS, SIGNS, SIGNBOARDS AND BILLBOARDS AND FOR OTHER PURPOSES", FOR THE REASON THAT SAID ORDINANCE IS IN CONFLICT WITH SECTION 152 PARAGRAPH (A) OF THE LOCAL GOVERNMENT CODE OF 1991 FIXING THE TAX TO BE IMPOSED AT NOT MORE THAN ONE (1%) PER CENT;

ADOPTED, March 16, 2000.
