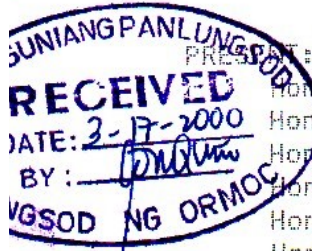

RESOLUTION NO. 2000-046

A RESOLUTION AUTHORIZING THE HONORABLE CITY MAYOR,  
EUFROCINO M. CODILLA, SR., IN BEHALF OF THE CITY  
GOVERNMENT OF ORMOC, TO SIGN A DEED OF DONATION INFAVOR  
OF THE LIGA NG MGA BARANGAY NG ORMOC PERTAINING TO A  
PARCEL OF LAND CONTAINING FIVE HUNDRED (500) SQUARE  
METERS, PER SKETCH PLAN WITH TECHNICAL DESCRIPTION  
PREPARED BY GEODETIC ENGINEER DARLITO A. PAREJA,  
LOCATED AT THE GOVERNMENT CENTER, BARANGAY COGON, THIS  
CITY, TO BE USED AS THE SITE OF THE ABC HALL, SUBJECT  
TO THE CONDITION HEREINBELOW STATED.

WHEREAS, this august Body is in receipt of 3rd Indorsement dated 9  
March 2000 from the Honorable City Mayor Eufrocino M. Codilla, Sr., re:  
Resolution No. 05 s. 1998 of the Liga Board of Directors, Ormoc City  
entitled: "A RESOLUTION EARNESTLY REQUESTING THE CITY GOVERNMENT OF  
ORMOC THRU THE HONORABLE CITY MAYOR, EUFROCINO M. CODILLA, SR., TO  
DONATE A 500 SQ. METER LOT TO SERVE AS SITE OF THE ABC HALL, ORMOC  
CITY";

WHEREAS, in view of the availability of a lot for the purpose, the  
Honorable Members of the Sangguniang Panlungsod ng Ormoc have reached  
out consensus on the following points:

- A consensus to follow the existing policy on giving 500 square  
meters only to those asking for donation from the city  
government.
- A consensus that, in the Deed of Donation, the donee should be  
the Liga ng mga Barangay ng Ormoc;
- And further, that a provision should be incorporated in the  
Deed of Donation requiring the Liga ng mga Barangay ng Ormoc  
to construct a building within one (1) year from date of  
execution of the Deed of Donation and that the land donated



should be used exclusively for the proposed ABC Hall, otherwise, the ownership of the property donated shall revert to the City Government of Ormoc.

WHEREFORE, foregoing premises considered, on motion of City Councilor Mariano Y. Corro, Chairman, Committee on Public Properties, jointly seconded by City Councilors Alfredo F. Capahi and Dennis Y. Capuyan; be it

RESOLVED, AS IT IS HEREBY RESOLVED, to pass a resolution AUTHORIZING THE HONORABLE CITY MAYOR, EUFROCINO M. CODILLA, SR., IN BEHALF OF THE CITY GOVERNMENT OF ORMOC, TO SIGN A DEED OF DONATION INFAVOR OF THE LIGA NG MGA BARANGAY NG ORMOC PERTAINING TO A PARCEL OF LAND CONTAINING FIVE HUNDRED (500) SQUARE METERS, PER SKETCH PLAN WITH TECHNICAL DESCRIPTION PREPARED BY GEODETIC ENGINEER DARLITO A. PAREJA, LOCATED AT THE GOVERNMENT CENTER, BARANGAY COGON, THIS CITY, TO BE USED AS THE SITE OF THE ABC HALL, SUBJECT TO THE CONDITION HEREINBELOW STATED;

ADOPTED, March 16, 2000.

RESOLVED, FURTHER, to furnish copies of this resolution, one each to His Honor, the City Mayor; the City Administrator, the City Legal Officer, the City Treasurer, the City Assessor, the City Engineer, two copies for the Liga ng mga Barangay ng Ormoc, and others concerned, -in Ormoc City.
