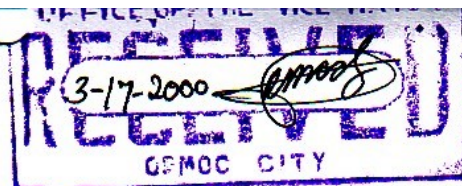

RESOLUTION NO. 2000-048

A RESOLUTION AUTHORIZING THE CITY ACCOUNTANT TO CHARGE
THE AMOUNT OF ONE HUNDRED FIFTY THOUSAND PESOS
(P150,000.00) AS AID TO VICTIMS OF MAYON VOLCANO
ERUPTION TO BE TAKEN FROM THE ACCOUNT - GRANTS,
SUBSIDIES AND CONTRIBUTIONS UNDER THE OFFICE OF THE
CITY MAYOR.

WHEREAS, this august Body is in receipt of a letter dated 8 March 2000 from the Honorable City Mayor Eufrocino M. Codilla, Sr., addressed the Honorable Members, 8th Sangguniang Panlungsod, this city, requesting for the passage of resolution authorizing him to release the amount of ONE HUNDRED FIFTY THOUSAND PESOS (P150,000.00) as relief assistance to the victims of Mayon Volcano eruption;

WHEREAS, the City Budget Officer through 3rd Indorsement dated 10 March 2000 has stated that authority be granted to release the said sum of ONE HUNDRED FIFTY THOUSAND PESOS (P150,000.00) as aid to victims of Mayor Volcano eruption to be taken from the account grants, subsidies and contributions - under the Office of the City Mayor;

WHEREAS, the City Accountant through 5th Indorsement has informed the Honorable Chairman, Committee on Finance that Fund Balance of Account - Grants, Subsidies and Contributions - RESERVE under the Office of the City Mayor is THREE HUNDRED NINETY THOUSAND PESOS (P390,000.00);

WHEREAS, the ICO-City Treasurer through 7th Indorsement has stated that fund is available subject to accounting and auditing rules and procedures;

WHEREFORE, foregoing premises considered, on motion of City Councilor Alfredo F. Capahi, Chairman, Committee on Finance, jointly seconded by City Councilors Claudio P. Larrazabal and Jose C. Alfaro, Jr.; be it

RESOLVED, AS IT IS HEREBY RESOLVED, to pass a resolution AUTHORIZING THE CITY ACCOUNTANT TO CHARGE THE AMOUNT OF ONE HUNDRED FIFTY THOUSAND PESOS (P150,000.00) AS AID TO VICTIMS OF MAYON VOLCANO ERUPTION TO BE TAKEN FROM THE ACCOUNT - GRANTS, SUBSIDIES AND CONTRIBUTIONS UNDER THE OFFICE OF THE CITY MAYOR;

ADOPTED, March 16, 2000.
