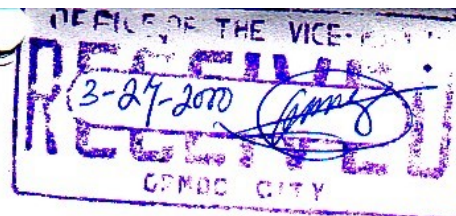
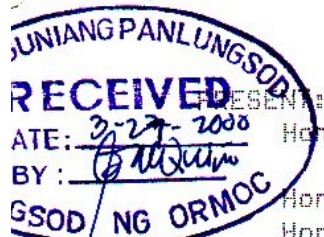

A RESOLUTION RESPECTFULLY REQUESTING THE APPRAISAL
COMMITTEE THROUGH ITS CHAIRMAN, TO FORMULATE AND ADOPT
THE CRITERIA, STANDARDS AND GUIDELINES AS BASIS IN THE
APPRAISAL OF PROPERTIES SOUGHT TO BE ACQUIRED FOR ROAD
RIGHT OF WAY PURPOSES AND TO FURNISH THIS
SANGGUNIANG COPY THEREOF.

WHEREAS, acquisitions of properties by the City Government for road
right of way purposes are referred to this Sanggunian for the grant of
authority to the City Mayor to sign the Deed of Acquisition;

WHEREAS, one of the documents attached to the request for authority
to the City Mayor to sign the Deed of Acquisition is the Appraisal
Committee's Report;

WHEREAS, the aforementioned Appraisal Committee's Report does not
contain any information on how the appraised value of the property
sought to be acquired was arrived at;

WHEREAS, in view of the aforementioned deficiency, it is recommended
that the Appraisal Committee formulate and adopt the criteria, standards
and guidelines as basis in the appraisal of the properties sought to be
acquired for road right of way purposes, so that the appraisal thereof
will be objective, fair and equitable;
