## RESOLUTION NO. 2000-054

A RESOLUTION PARTIALLY REORGANIZING THE CHAIRMANSHIP AND MEMBERSHIP OF THE STANDING COMMITTEES OF THE EIGHTH SANGGUNIANG PANLUNGSOD NG ORMOC, AND THE ASSIGNMENT OF THE KAGAWAD-IN-CHARGE ON THE EIGHT BARANGAYS, IN VIEW OF THE RECENT APPPOINTMENT OF COUNCILOR FE S. LLADOC, THEREBY AMENDING ACCORDINGLY RESOLUTION NO. 99-77 DATED MAY 20, 1999.

WHEREAS, this Sanggunian passed SP Resolution No. 99-77 on May 20, 1999 entitled: "A RESOLUTION PARTIALLY REORGANIZING THE CHAIRMANSHIP AND MEMBERSHIP OF THE STANDING COMMITTEES OF THE EIGHTH SANGGUNIANG PANLUNGSOD NG ORMOC, AND THE ASSIGNMENT OF THE KAGAWAD-IN-CHARGE ON THE EIGHT BARANGAYS, IN VIEW OF THE UNTIMELY DEMISE OF COUNCILOR BENJAMIN B. LLADOC, THEREBY AMENDING ACCORDINGLY RESOLUTION NO. 98-06 RE: ORGANIZATION OF STANDING COMMITTEE, ETC";

WHEREAS, this august Body during its Pre-Session Caucus on March 20, 2000, has reached a consensus to partially reorganize the chairmanship and membership of the Standing Committees, as well as the reassignment of the Kagawad-In-Charge on the eight barangays previously assigned to the late Benjamin B. Lladoc, be given to newly appointed Councilor Fe S. Lladoc for the good of the service and governance;

WHEREFORE, on motion of City Councilor Mariano Y. Corro, Chairman, Committee on Internal Rules, severally seconded by City Councilors Sotero M. Pepito, Dennis Y. Capuyan and Alfredo F. Capahi; be it

RESOLVED, AS IT IS HEREBY RESOLVED, to pass a resolution partially reorganizing the chairmanship and membership of the standing committees of the Eighth Sangguniang Panlungsod ng Ormoc, and the assignment of the Kagawad-In-Charge on the eight barangays, previously assigned to the late City Councilor Benjamin B. Lladoc, thereby amending accordingly Resolution No. 99-77 dated May 20, 1999 in the following manner:

A. <u>STEERING COMMITTEE</u> - CHAIRMAN: Councilor Fe S. Lladoc; VICE-CHAIRMAN: Councilor Sotero M. Pepito; MEMBERS: All Councilors.

AGRICULTURAL & INDUSTRIAL LABOR - CHAIRMAN: Councilor Fe S. Lladoc; VICE-CHAIRMAN: Councilor Mariane Y. Corro; MEMBERS: Councilors Dennis Y. Capuyan Eduardo P. Tan, Fernando P. Parrilla and Alfredo F. Capahi.

- B. City Councilor Fe Lladoc shall be a member of the following Standing Committees, namely: Finance as Vice Chairman; Trade and Commerce, Public Properties, Urban Development, Ways & Means, Laws & Ordinances, Manpower Development and General Services.
- C. The Barangays which were previously assigned to Councilor Fernando P. Parrilla, namely: Sto. Niño, Salvacion, Masunogan, Cagbuhangin, Milagro, Luna, Dolores and Catmon are now reassigned to Councilor Fe S. Lladoc.
