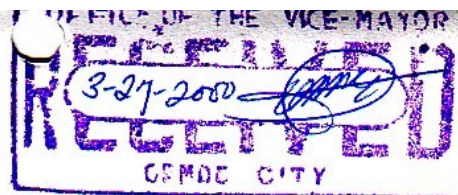

1999 TO READ AS FOLLOWS: "A RESOLUTION APPROVING THE
REALIGNMENT OF CONSTRUCTION OF BASKETBALL COURT AND
STAGE OF BRGY. VALENCIA IN THE AMOUNT OF FOUR HUNDRED
THOUSAND PESOS (P400,000.00) UNDER THE 1998 CEO FUND TO
BARANGAY ROAD OPENING AT BRGY. BAGONG IN THE SAME
AMOUNT AND REQUESTING THE HONORABLE SANGGUNIANG
PANLUNGSOD FOR THE APPROVAL OF THE SAME, TO REVERSION
OF FOUR HUNDRED THOUSAND PESOS (P400,000.00) FROM THE

WHEREAS, CDC Executive Resolution No. 2 s. 2000 mentions that as recommended by the City Budget Officer the utilization of a continuing appropriation not under the same year is a reversion;

WHEREAS, the ICO-City Treasurer, Mrs. Salud A. Rivera, through 6th Indorsement has stated that fund is available to be charged against the reversion of the construction of basketball court and stage at Brgy. Valencia '98 continuing appropriation of the City Engineer's Office of same amount, subject however to accounting and auditing procedures;

WHEREFORE, foregoing premises considered, on motion of City Councilor Claudio P. Larrazabal, Chairman, Committee on Infrastructures, severally seconded by City Councilors Sotero M. Pepito, Fernando P. Parrilla and Alfredo F. Capahi; be it
