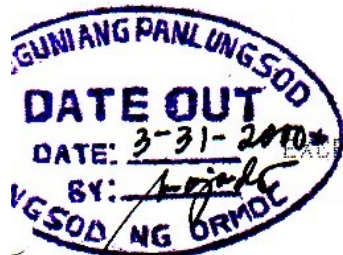
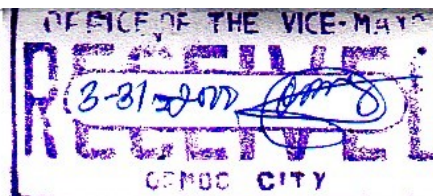
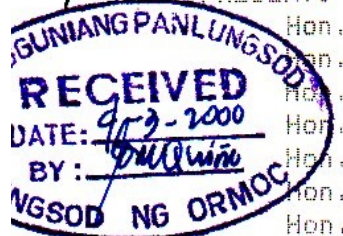

HUNDRED EIGHTY SEVEN PESOS & 51/100 (P2,687.51)
REPRESENTING UNPAID ISLACOM BILLS OF THE CITY BUDGET
OFFICE, COVERING THE PERIOD FROM DECEMBER 1998 TO
DECEMBER 1999.
