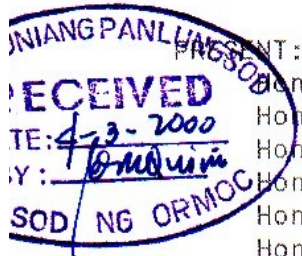

A RESOLUTION RESPECTFULLY REQUESTING CITY LEGAL OFFICER,
ATTY. CLETO L. EVANGELISTA, JR., INFORMATION ON THE
STATUS OF THE REAL PROPERTY TAX LIABILITY OF TAIPAN
DEVELOPMENT CORPORATION, INC., ON THE BUILDING OF THE
GAISANO-ORMOC SHOPPING MALL, AND HIS PLAN OF ACTION
THEREON, CONSIDERING THE POSITION OF TAIPAN ON THE
MATTER.

WHEREAS, efforts have been exerted by the City Government of Ormoc
to collect from TAIPAN DEVELOPMENT CORPORATION, INC. the real property
tax on the building of the Gaisano-Ormoc Shopping Mall, but is being
resisted by the latter, as it is their view that they are not liable
thereon;

WHEREAS, the members of this Sanggunian desire to have an updated
information on the status of this controversial issue, as well as the
planned course of action and/or strategies adopted on the premises;

Jr. and Alfredo F. Capahi; be it -


RESOLVED, AS IT IS HEREBY RESOLVED, to pass a resolution
