RESOLUTION RETURNING TO THE BARANGAY COUNCIL OF MATICA-A, THIS CITY THEIR BARANGAY RESOLUTION NO. 08 S. 2000, ENTITLED: "A RESOLUTION EARNESTLY REQUESTING THE CITY MAYOR HON. EUFROCINO M. CODILLA, SR., THRU THE SANGGUNIANG PARLUNGSOD NG ORMOC THE APPROVAL TO AMEND A RESOLUTION BARANGAY RESOLUTION NO. 7 S. 1992 AND TAX ORDINANCE NO. 3 S. 1992 TO INCREASE FROM ONE PERCENT (1%) TO THREE RERCENT (3%) AND TO LEVY TAXES, FEES AND CHARGES PURSUANT TO SEC. 152, SECTION 153 AND SECTION 391 PARAGRAPH (1) OF THE LOCAL GOVERNMENT CODE OF 1991", FOR THE REASON THAT IT IS VIOLATIVE OF SEC. 152 OF LOCAL CODE AND THAT IT SHOULD BE THE BARANGAY COUNCIL ITSELF THAT WILL MAKE THE AMENDATORY ORDINANCE AND FURTHER, TO CALL THEIR ATTENTION THAT THE \$10.00 BASIC FOR COMMUNITY TAX CERTIFICATE IS IN ALLOWABLE BY LAW.

WHEREAS, this Sanggunian is in receipt of Barangay Resolution No. 7 1992, entitled: "A RESOLUTION EARNESTLY REQUESTING THE CITY MAYOR HON. EUFROCINO M. CODILLA, SR., THRU THE SANGGUNIANG PANLUNGSOD NG ORMOC THE APPROVAL TO AMEND BARANGAY RESOLUTION NO. 7 S. 1992 AND TAX ORDINANCE NO. 3 S. 1992 TO INCREASE FROM ONE PERCENT (1%) TO THREE PERCENT (3%) AND TO LEVY TAXES, FEES AND CHARGES PURSUANT TO SEC. 152, SECTION 153 AND SECTION 391 PARAGRAPH (1) OF THE LOCAL GOVERNMENT CODE OF 1991";
