A RESOLUTION RETURNING TO THE BARANGAY COUNCIL OF CATMON,
THIS CITY, THEIR BARANGAY ORDINANCE NO. 04 ENTITLED:
"AN ORDINANCE AUTHORIZING THE INCREASE OF BARANGAY
BUSINESS CLEARANCES AND OTHER FEES AND CHARGES", FOR
THE REASON THAT THIS SANGGUNIAN WOULD LIKE TO BE
CLARIFIED AS TO WHAT THE P5.00 BARANGAY CLEARANCE FEE
INTENDED FOR.

WHEREAS, this Sanggunian is in receipt of Ordinance No. 04 of the
Barangay Council of Catmon, this city, entitled: "AN ORDINANCE
AUTHORIZING THE INCREASE OF BARANGAY BUSINESS CLEARANCES AND OTHER FEES
AND CHARGES";

WHEREAS, the Sangguniang Panlungsod ng Ormoc is by law granted the
Power of Review as to whether said Ordinance is consistent by law and
city ordinances (Sec. 57, 1991 LGC);

WHEREAS, upon review of said Ordinance by this august Body it was
found out that said ordinance is vague, hence, a clarification has to be
made as to what is the P5.00 fee intended for and that the provision on
Lupon Tagapayapa fee be indicated in a separate section of the ordinance
not under the barangay clearance fee;

WHEREFORE, foregoing premises considered, on motion of City
Councilor Nepomuceno P. Aparis I, Chairman, Committee on Laws &
Ordinances, jointly seconded by City Councilors Mariano Y. Corro and
Dennis Y. Capuyan; be it

RESOLVED, AS IT IS HEREBY RESOLVED, to pass a resolution RETURNING TO THE BARANGAY COUNCIL OF CATMON, THIS CITY, THEIR BARANGAY ORDINANCE NO. 04 ENTITLED: "AN ORDINANCE AUTHORIZING THE INCREASE OF BARANGAY BUSINESS CLEARANCES AND OTHER FEES AND CHARGES", FOR THE REASON THAT THIS SANGGUNIAN WOULD LIKE TO BE CLARIFIED AS TO WHAT THE ₱5.00 BARANGAY CLEARANCE FEE INTENDED FOR;
