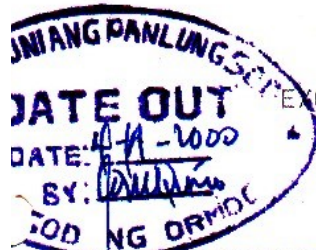

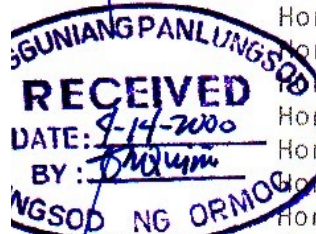

RESOLUTION NO. 2000-067

A RESOLUTION RETURNING TO THE BARANGAY COUNCIL OF CAMP DOWNES, THIS CITY, THEIR BARANGAY ORDINANCE NO. 02 S., 2000, ENTITLED: "AN ORDINANCE IMPOSING CURFEW HOURS FROM 10:00 O'CLOCK IN THE EVENING TO 4:00 O'CLOCK IN THE MORNING TO PERSONS UNDER 20 YEARS OF AGE AND PROVIDING PENALTIES FOR VIOLATION THEREIN" FOR THE REASON THAT THE AGE OF MAJORITY UNDER THE LAW IS 18 YRS. OLD AND NOT 20 YRS. OLD AS STATED THEREIN.

WHEREAS, this Sanggunian is in receipt of Ordinance No. 02 s. 2000, entitled: "AN ORDINANCE IMPOSING CURFEW HOURS FROM 10:00 O'CLOCK IN THE EVENING TO 4:00 O'CLOCK IN THE MORNING TO PERSONS UNDER 20 YEARS OF AGE AND PROVIDING PENALTIES FOR VIOLATION THEREIN";

WHEREAS, the Sangguniang Panlungsod ng Ormoc is by law granted the Power of Review as to whether said ordinance is consistent with law and city ordinances (Sec. 57, 1991 LGC);

WHEREAS, upon review of said Ordinance by this august Body, it was found out that same is defective, considering that the age of majority as mentioned therein is 20 yrs. old. Under the law, the age of majority is 18 yrs. old;

WHEREAS, for the information and guidance of the Barangay Council of Camp Downes, attached herewith is a copy of the city ordinance imposing curfew on minors;

WHEREFORE, foregoing premises considered, on motion of City Councilor Nepomuceno P. Aparis I, Chairman, Committee on Laws & Ordinances, jointly seconded by City Councilors Sotero M. Pepito and Dennis Y. Capuyan; be it
