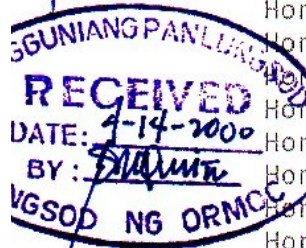

seconded by Councilors Dennis Y. Capuyan and Sotero M. Pepito; be it


RESOLVED, AS IT IS HEREBY RESOLVED, to pass a resolution

ADOPTED, April 13, 2000.


