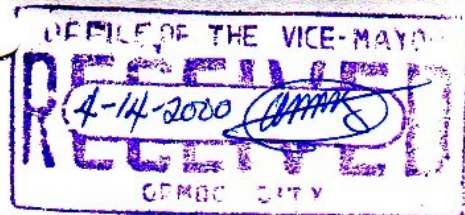


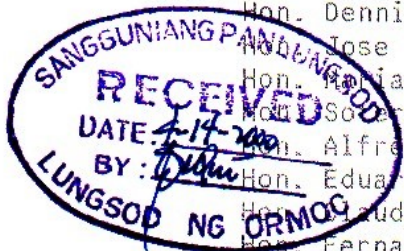

RESOLUTION NO. 2000-071

A RESOLUTION RETURNING SUPPLEMENTAL BUDGET NO. 01 OF
BARANGAY DISTRICT 15 AND BARANGAY DISTRICT 27, THIS
CITY.

WHEREAS, this Sanggunian is in receipt of Supplemental Budget No.
01 of Barangay District 15 and Barangay District 27, this city for
review action;

WHEREAS, upon review of said budgets, this august Body decided to
return the same to their to respective barangay of origin with the
information that this Sanggunian cannot act favorably on these budgets
for the reason that the purchase of medicines under the 20% development
fund is not allowed per Executive Order No. 189 dated December 21, 1999;

WHEREAS, Section 1 of Executive Order No. 189 is quoted hereunder
as follows:

"Section 1. Use of the 20% Development Fund. The
Internal Revenue Allotment (IRA) share of local government
units equivalent to twenty percent (20%) set aside for
development projects shall be used for specific sectoral
program, projects and activities in furtherance of the
development agenda for the government. X X X" (Underscoring
supplied)

WHEREFORE, foregoing premises considered, on motion of City
Councilor Nepomuceno P. Aparis I, Chairman, Committee on Laws and
Ordinances, duly seconded by City Councilor Mariano Y. Corro; be it

RESOLVED, AS IT IS HEREBY RESOLVED, to pass a resolution RETURNING SUPPLEMENTAL BUDGET NO. 01 OF BARANGAY DISTRICT 15 AND BARANGAY DISTRICT 27, THIS CITY;

ADOPTED, April 13, 2000.

RESOLVED, FURTHER, to furnish copies of this resolution each to the ABC President, the Barangay Chairman of Barangay District 15 and Barangay District 27 and others concerned, -in Ormoc City;
